INTRODUCTION

The Metropolitan Transportation Commission (MTC) hereby submits the Disadvantaged Business Enterprise (DBE) Triennial Goal and Methodology for Federal Fiscal Year (FFY) 2026 through 2028.

MTC is the transportation planning, financing and coordinating agency for the nine-county San Francisco Bay Area. As a recipient of Federal Transit Administration (FTA) funding to subsidize capital and/or operating transit related activities, MTC is required to submit an overall goal for DBE participation over the upcoming three federal fiscal years. The overall DBE goal of 7% contained herein represents anticipated DBE participation in FTA-assisted activity for FFY 2026 to FFY 2028 to be achieved through 4% race (and gender)-neutral and 3% race (and gender)-conscious means.

BACKGROUND

The DBE overall goal setting methodology is a requirement set forth in the United States Department of Transportation (USDOT) DBE regulations, 49 Code of Federal Regulation (CFR) Part 26.45. The DBE regulations require USDOT recipients to set an overall goal based on demonstrable evidence of the availability of ready, willing and able DBEs relative to all businesses ready, willing and able to participate on DOT assisted contracts. The goal must reflect MTC's determination on the level of DBE participation expected absent the effects of discrimination. These regulations define the components that are addressed and incorporated into MTC's DBE Program.

FTA-Assisted Contracting for FFY 2026 - 2028

The DBE regulations state that the overall goal should be expressed as a percentage of all FTA funds (excluding the purchase of transit vehicles) that MTC (and subrecipients under MTC's oversight) will expend in FTA-assisted contracts over the next three federal fiscal years. MTC receives various levels of FTA formula funding directly from FTA and indirectly from California Department of Transportation (Caltrans) and other FTA transit grantees. MTC is the region's designated recipient of FTA formula programs for large, urbanized areas and has programming authority for small, urbanized areas via agreement with Caltrans. Ongoing FTA grants with MTC include Clipper Fare Collection and Mapping & Wayfinding, both funded through Section 5307 formula funds and Federal Highway Administration (FHWA) funds transferred to FTA.

MTC has executed memoranda of understanding with area FTA grantees establishing procedures to ensure FTA contracting activity is captured appropriately in FTA DBE goals and Uniform Reports.

The dollar amounts in Table 1 reflect the full contract amount for each project, as opposed to only the FTA funded share, because the FTA funded percentage in MTC contracts is uncertain until project solicitation.

GOAL METHODOLOGY

DBE regulations require that MTC include with the overall goal submission a description of the methodology used to establish the goal, including the base figure and the evidence with which it was calculated, and the adjustments made to the base figure, if any, and evidence relied upon for the adjustments. This section outlines the process utilized to establish the step-one base figure and consideration given to determine if a step-two adjustment of the base figure is necessary.

Establishment of Local Market Area

Figure A, Map of Bay Area Nine Counties:

The US DOT Tips for Goal Setting recommends explaining how the local market area was determined. The local market area is the area in which the substantial majority of the contractors and subcontractors with which MTC does business are located, and the area in which MTC spends the substantial majority of its contracting dollars. As previously mentioned, MTC is the coordinating agency in the nine-county San Francisco Bay area. The local market area was determined to be the nine counties in the San Francisco Bay area based on MTC expenditures. Figure A illustrates the nine counties in MTC’s local market area. These counties include Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, Santa Clara, Solano and Sonoma.

Step One: Determination of Base Figure I

MTC examined various sources identified in the US DOT Tips for Goal Setting to measure relative availability data. MTC determined that the California Unified Certification Program (CUCP) DBE directory and US Census data were the most appropriate sources available to estimate the relative availability of DBEs and non-DBEs in the market area. Weighting of project activity with the applicable North American Industry Classification System (NAICS) code is encouraged by the

US DOT Tips for Goal Setting to ensure the step one base figure is as accurate as possible. Table 2 represents contracting opportunities broken down by NAICS codes with the weighted amounts for the FFY 2026-2028 projects.

The scope of work for the current triennial period has changed substantially from the previous cycle. The Regional Mapping and Wayfinding Project Pilot now comprises approximately 80% of the total contract value, with over \$20 million allocated primarily to sign manufacturing. In contrast, the remaining contracts total approximately \$6 million and are focused on professional services, including market research and management consulting.

This disproportionate distribution has significantly skewed the overall contract composition. To address this imbalance, it is recommended that the Regional Mapping and Wayfinding Project Pilot be treated as a standalone project with a separate DBE goal applied. Additionally, the triennial DBE goal has been recalibrated to reflect the scope of the remaining professional services contracts more accurately, resulting in a revised base goal of 1%.

The step one weighted base figure is derived by multiplying the category weight by the relative availability as shown in the equation below.

The base figure was calculated using the methods prescribed in the US DOT Tips for Goal Setting, with ready, willing and able DBEs as the numerator in each work category and all firms (DBEs and non-DBEs) as the denominator. MTC examined the relationship between relative availability and size of projects during the triennial period. Through incorporation of weighting, MTC further refined the data based on relative availability for applicable projects. After establishing weights, MTC determined the best sources for DBEs and census data were the California Unified Certification Program (CUCP) and US County Business Patterns, respectively.

Step Two: Adjusting the Base Figure

Once the base figure is calculated, the DBE regulations require that MTC examine all the evidence available in its jurisdiction to determine what adjustment, if any, is needed for the base figure to arrive at the overall goal. If the evidence does not suggest an adjustment is necessary, then no adjustment shall be made. Several factors must be considered in making step two adjustments to the base figure. MTC considered the following factors for a step two adjustment:

- Past participation (the volume of work DBEs have performed in recent years) or other measures of demonstrated capacity; and
- Evidence from disparity studies conducted in the market area (including relevant studies commissioned by other contracting agencies in the market area).

The *US DOT Tips for Goal Setting* suggests that consideration be given to disparity study data conducted in the market area. A disparity study was commissioned by Caltrans to determine if any disparities existed in its FTA-assisted contracting activities. The disparity study final report was issued on November 10, 2022, and is available to the public on Caltrans' website: <https://dot.ca.gov/programs/civil-rights/disparity-study>. (Consulting, 2022)

Past Participation

MTC examined the volume of work committed to DBEs on MTC's FTA-funded projects from FFY 2022-2024.

- FFY 2021-2022: Actual DBE Participation equaled 24.40%
- FFY 2022-2023: Actual DBE Participation equaled 14.38%
- FFY 2023-2024: Actual DBE Participation equaled 0%

Using adjustments based on past participation as a means of adjusting the step one base figure, we determined the median past participation figure to be 14.38%.

Formula Steps

1. FFY 2026-2028 Base Figure with Wayfinding Contract = 23.8%, this contract will have a DBE goal calculated and applied to it;
2. FFY 2026-2028 Base Figure without Wayfinding Contract = 1%;
3. Median Past Participation = 14.38%;
4. Adjustment Factor = (base figure 1%) + (median of past participation 14.38%) divided by 2 = 7.69%. The recommended adjusted goal is 7%.

In addition, MTC reviewed the contents of the disparity study and considers the information to be relevant based on the similarity of MTC’s FTA-assisted contracting activities to those of Caltrans. The availability of minority and women-owned businesses considered together is highest for professional services contract (46.7%) and lowest for transit services contract (21.5%), with an industry weight of 0.4%.

“Caltrans and relevant subrecipient local agencies awarded in FFYs 2018, 2019 and 2020. During that time, certified DBEs received 0.4 percent of dollars on Caltrans’ FTA-funded contracts. That information supports a downward adjustment to Caltrans’ base figure. If Caltrans uses an approach similar to what USDOT outlines in “Tips for Goals Setting” to adjust its base figure based on past DBE participation, it will take the average of its 21.6 percent base figure and the 0.4 percent past DBE participation, yielding an overall DBE goal of 11.0 percent (Chapter ES, page 4).” (Consulting, 2022)

After evaluating all of the above data, MTC concluded that a downward adjustment to the overall base figure was warranted.

Public Participation

In establishing an overall goal, MTC must provide consultation and publication. This includes: (1) consultation with minority, women's and general contractor groups, community organizations, and other officials or organizations that could be expected to have information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBEs, and MTC’s efforts to establish a level playing field for the participation of DBEs; and (2) a published notice announcing MTC’s proposed overall goal before submission to FTA. The notice must be posted on MTC’s official website. If the proposed goal changes following review by the FTA, the revised goal must be posted on MTC’s official website.

Consultation

The MTC, in collaboration with the Business Outreach Committee (BOC), conducted two virtual and one in-person consultation meetings to engage stakeholders throughout the San Francisco Bay Area. Invitations were extended to a diverse array of organizations, including trade associations, ethnic chambers of commerce, builders' exchanges, community groups, and women's and technical resource organizations. Participants included representatives from the U.S. Small Business Administration, SCORE, NorCal PTAC, various local builders' exchanges, and numerous women and minority focused business organizations.

Topics discussed during the consultation meetings included MTC's step-two adjustment methodology, challenges DBEs face in securing bonding, the availability of contracting opportunities for DBEs, and recommendations for race-conscious contracting practices. Comments were received and documented; however, none warranted changes to MTC's goal-setting methodology. Records of the consultation process, including the list of invited, attending organizations, and comments received are included in Appendix A – Consultation Meeting.

Publication

MTC published a notice of its proposed DBE goal on its website prior to August 1, 2025, submission to the Federal Transit Administration. As permitted under DBE regulations, the proposed FFY 2026–2028 DBE goal and methodology were made available for public inspection online, with a 30-day comment period. All comments received will be reviewed to determine whether any revisions to the proposed goal are necessary. Supporting documentation is provided in Appendix B – Publication.

PROPOSED OVERALL DBE GOAL BREAKDOWN

The proposed overall FFY 2026-2028 DBE Goal for the MTC is 7%, which is one percentage point above the previous 6% DBE goal submitted to FTA on August 1, 2023.

The DBE regulations require a projection of the portions of the overall goal expected to be met through race (and gender)-neutral and race (and gender)-conscious measures. Regulations additionally require that the maximum feasible portion of the overall goal be attained through race (and gender)-neutral measures.

MTC has continued to rely upon the 2022 Caltrans Disparity Study for FTA Contracts, the most recent complete study. The 2022 Caltrans disparity study analysis determined that only 0.4% of contract dollars were awarded to certified DBEs without the use of contracts goals. The initial findings from the study indicate that there is continued evidence of discrimination in the contracting industry that would meet the standards set forth by the 9th Circuit Court and support the usage of race-conscious goals on MTC's federally funded contracts. Based on MTC past participation, MTC will presume that it can meet part of its overall goal of 7% through race (and gender)-neutral measures.

MTC proposes an overall triennial DBE goal of 7%, with a 3% race-conscious and 4% race neutral split based on the projected availability of ready, willing and able DBEs. MTC proposes to implement its FFY 2026-2028 overall DBE goal of 7% with a race-conscious and race-neutral split that will include individual contract goals and good faith efforts requirements based on findings of discrimination on Caltrans' 2022 Disparity Study and on current and recent utilization of DBEs on

FTA assisted contracts. MTC will continue to monitor FTA assisted contracts to determine how contract goals will be applied. MTC projects will meet the maximum feasible portion of their overall goal through race-neutral means.

RACE CONSCIENCE AND NEUTRAL IMPLEMENTATION MEASURES

In calculating the race neutral and race conscience split, MTC considered the amount by which it exceeded its goals in the past. MTC's race neutral achievements over the past years are as follows:

- FFY 2021-2022: Actual 0% RN and 24.4% RC due to past participation
- FFY 2022-2023: Actual 0% RN and 14.38% RC due to past participation
- FFY 2023-2024: Actual 0% RN and 0% RC due to past participation

The median race neutral achievement is 0% over the last three years. MTC considered guidance from US DOT to analyze past participation by DBE prime contractors in race neutral calculation. From the last three years, zero DBE primes have been identified to receive awards for professional services contracts. MTC will take extra measures to monitor the award of contracts to small business firms to capture race neutral means moving forward.

In calculating the overall DBE goal, MTC determined that it is reasonable to expect in the absence of discrimination, that 4% of the proposed 7% DBE goal could be achieved through race neutral contribution. MTC will continue the use of race-conscious goals in conjunction with race neutral means. MTC sets DBE numerical contract goals on FTA and FHWA-assisted contracts where goals need to be set. Race neutral means include, but are not limited to, the following:

- The MTC website (<https://mtc.ca.gov/jobs-contracts/contract-vendor-opportunities>) has been made easier to navigate and includes information on current, upcoming, and recently awarded contracts including awardees and contract amount. The website allows firms to register online to receive notifications of procurements when they are issued.
- MTC's DBE program, BOC newsletters, "Tips for Responding to MTC Procurements," notices of upcoming events, and information on projects that receive funding from MTC, but are administered and contracted through other transportation and local agencies in the nine-county Bay Area are also posted on the website.
- Facilitating DBE and other small business participation by unbundling large contracts to make them more accessible to small businesses, requiring or encouraging prime contractors to subcontract portions of work that they might otherwise perform with their own forces.
- Monitor contracts to ensure attainment of the contract assigned goals.

MTC will monitor its overall DBE goal by tracking each contract throughout the term for DBE participation and payments respective to the federal fiscal year of the award.

MTC emails notices of procurements to DBEs, and as a member of the BOC and Caltrans District 4 Calmentor program, MTC actively participates with other agencies in DBE and SBE outreach efforts. Events that MTC planned and/or participated in the last federal fiscal year include:

Consultation

In an effort to provide public participation in the goal-setting process, MTC worked in concert with other U.S. DOT recipients in the region as members of the BOC in order to solicit and receive public comments. The BOC and MTC sent out email invitations and newsletters for the consultation meeting and public participation sessions held on May 7, 2025 that were hosted via Eventbrite, a webinar platform at 10:00 a.m. and again at 12:00 p.m.; the third public participation meeting on May 13, 2025 was hosted in person by MTC at 11:00 a.m. Invitations to the consultation meetings were sent out electronically on April 21, 2025 to over one hundred and

fifty (150) Community Based Organizations and resource centers, and again on April 30, 2025 to over 10,000 businesses which included firms from the CUCP database, and MTC vendor databases. Furthermore, the event flyer was posted on the BOC and MTC websites.

The BOC and MTC confirmed fifty-one (51) registered firms and agencies for the morning virtual session, of which, thirty-eight (38) participants attended the session with ten (10) firms from CBOs, and the remaining twenty-eight (28) were BOC members. The afternoon session confirmed ninety-two (92) registered firms and agencies for the virtual session, of which, fifty (50) participants attended the session with thirty (30) firms from the public, and the remaining twenty (20) were BOC members.

Firms that participated in the sessions provided the following comments:

- From your perspective, what are the most significant barriers DBEs in your community face when trying to access DOT-funded contracting opportunities?
- What suggestions do you have for agencies to work together with your organizations/clients to level the playing field?
- Consider hosting more Meet the Prime events or programs. There are many DBEs who do not have the experience to connect with other businesses.

Public Participation Meetings

The Public Participation meetings were open to the public to receive comments and questions on the overall goal setting process, discuss the proposed projected DBE goals from each participating agency, and answer any questions or concerns. The flyer was advertised in the Small Business Exchange between April 24, 2025 and April 30, 2025, and was promoted on BOC's event calendar and website at: <https://www.goldengate.org/district/doing-business/business-out-reach-committee/>.

The in-person consultation meeting that was held at MTC headquarters, 375 Beale Street, San Francisco, CA 94105 had twenty-four (24) registrations, of which ten (10) firms from the public attended and thirteen (13) BOC members. During the meeting, BOC members presented the overall goal-setting process and agencies proposed projected overall DBE goals and shared upcoming contracting opportunities for various agencies.

The BOC members provided the following questions to begin the discussion and receive feedback on issues within the DBE/SBE community, challenges to the DBE program, and improvements for agencies to better assist DBEs/SBEs:

- What are the major barriers for your members in competing for contracting opportunities?
- What trades are there a lack of/plethora of DBE participation?
- What are some recommended strategies to attract and increase DBE participation?

- Do you have suggestions for resources and references that agencies should develop, maintain, and disseminate to firms?

Firms that participated in the consultation meeting provided the following comments:

- One of the barriers is that some primes are reluctant to use DBE certified firms because they are new and/or do not have prior experience.
- Why do most transit agencies not list their DBE goals? A response was provided that several agencies were still finalizing their proposed goals and will host their own Public Participation Meetings.
- Small businesses mentioned they need help with bonding capacity and/or creating Joint Ventures.
- DBE firm mentioned they would like to see contracts unbundled further for them to bid or propose.

Mayor Bass Highlights Progress Rebuilding the Heart of the Palisades Ahead of Expectations

Los Angeles Mayor Karen Bass highlighted the completion of debris removal at the Palisades Branch Library, which was destroyed in the January wildfires. The U.S. Army Corps of Engineers cleared the property of all debris last week ahead of expectations following the Mayor's call to prioritize public spaces in the debris removal operation.

The Army Corps was expected to complete the debris removal process at the library in 30 days – they did it in 6 days. Photos and B-Roll available here.

Last week, Mayor Bass visited the Palisades Recreation Center across the street from the Palisades Library to announce a new public-private partnership with LA Strong Sports, Steadfast LA and key Palisades groups that will fund, redesign and rebuild the Recreation Center, which was partially destroyed and severely damaged during

January's wildfires. Earlier this month, the City announced that it had secured private funding to replace the Pacific Palisades playground.

"My top priority has been to get people home – that means rebuilding houses, but it also means rebuilding the places that make up the heart of this community," said Mayor Karen Bass. "These are city-owned properties and we've worked with the U.S. Army Corps of Engineers to prioritize debris removal at each of them, including the Palisades Branch Library, to expedite the timeline to get them rebuilt and returned to this community."

"I want to thank Colonel Brian Sawser, Captain Sheldon Tausch, and the U.S. Army Corps of Engineers for their service – our community is truly grateful for their commitment," said Councilwoman Traci Park. "It's critical that we stay focused on removing the roadblocks that slow down recovery. I'm glad to be working with the Mayor to keep these efforts moving forward so that we can help people get home faster."

"The Los Angeles Public Library is enormously grateful for Mayor Bass' leadership and for the Army Corps of Engineers' swift clearing of the site of our beloved Palisades Branch Library," said City Librarian John F. Szabo. "In a time of profound loss for so many, we recognize how fortunate we are to begin to look ahead. We appreciate the team's thoughtful attention to honor our requests for preserving elements of branch history, and we have a renewed sense of hope as we consider the possibilities for what comes next."

Mayor Bass highlighted the start of the rebuilding process in the Palisades last week by visiting two different sites that have been issued building permits from the City. The first permits were issued 57 days after the Palisades Fire began. The first permits took more than twice that time to be issued after both the Camp Fire and the Woolsey Fire.
