Application Introduction

General Information

This document contains instructions for completing the claim forms used to request an allocation from the following sources of funds:

- TDA Articles 4, 4.5 and 8
- STA Population and Revenue-based Funds
- AB 1107
- Feeder Bus
- Regional Measure 2 (RM2) Operating
- Regional Measure 3 (RM3) Operating

TDA forms and instructions are available for download from: www.mtc.ca.gov/tda

The TDA/STA claim form is a series of documents partially created through Excel spreadsheet and partially created by the claimant. Each Excel workbook is comprised of various tabs. The tabs in the Excel workbook provide most of the documents; the claimant produces other documents.

A single claim may be filed requesting TDA, STA, Feeder Bus, AB 1107, RM2, and RM3 funds. A single set of documents A, B and C will satisfy applications for any combination of TDA Articles or fund sources, if each fund source is clearly identified in these documents. The instructions for each document identifies which document must be completed and submitted depending upon the TDA Article(s) under which the claimant is claiming funds. Contact the TDA Program Manager if you have questions about which documents you need to include with your claim.

State Controller's Report and Fiscal Audit: All transit operators must provide MTC with a copy of their most recent State Controller's Report. All claimants must provide MTC with a copy of their most recent fiscal audit. If these documents have already been submitted, there is no need to send them again. The minimum lead-time required to process a claim is thirty days although sixty days is more typical. Claimants desiring a June allocation for expenses to occur starting in July must have submitted a complete and accurate claim to MTC staff no later than May 1st. This thirty-day lead-time also applies to each subsequent month; however, MTC does not typically allocate funds in

Summary of Claim Documents

Note: The documents below with “Spreadsheet” listed parenthetically in the title line are produced through the claim Excel workbook which contain a spreadsheet with the corresponding name of the Document. Documents with “Claimant” listed parenthetically in the title must be produced separately by the claimant.

Checklist 4, Checklist 4.5, Checklist 8 (Spreadsheet)

Though they are to the left of the A(a) tab (the tab document you must complete first), the Checklist tabs (4, 4.5, and 8) are intended to be completed after all of the claim documents have been compiled and completed. The Checklists are a way of confirming for yourself that your claim is complete before you submit it to MTC.

Document A(a) - Claimant Information (Spreadsheet)

Document A(a) provides contact information about the claimant, and specifies what modes are operated and the names of the various modes.

Document A(b) - Claim Summary (Spreadsheet)

Document A(b) Claim Summary summarizes the kinds of TDA, STA, AB 1107, Bridge Toll, and Feeder Bus funds that are requested, the claim purpose, the PUC number, the amount and the apportionment area from which the funds are being claimed. These amounts are summarized from information provided on tab F(a) of the spreadsheet, thus requiring no direct input.

Document A(c) Revenue Detail (Spreadsheet)

Document A(c) Revenue Detail is used to specify the exact type of funds being claimed. These funds are then automatically linked to Document F(a), Document F(c), and Document A(b). Because this document only provides information to other worksheets, it does not need to be included in the printed and signed claim.

Document B - Authorizing Resolution (Claimant)

Claimants are required to produce and submit an authorizing resolution.

Document C - Opinion of Counsel (Claimant)

Each claimant must produce and submit an Opinion of Counsel.

Document D - Environmental Documentation (Claimant)

All claimants are required to submit an environmental assessment for each project in their annual application.

Document E - Description of Claimant and Transit System (Claimant)

Each claimant must provide a description of the claimant and transit system. It is anticipated that much of the system and claimant description are included in Short Range Transit Plans that may be substituted in lieu Document E.

Document F(a) - Operating Expenses and Revenues (Spreadsheet)

Document F(a) is the essential financial reporting tab for operating expenses and revenues. It contains the cells within which operating expenses and revenues may be entered by transit mode. It summarizes these mode level entries to the system level. It also provides the cells for entering revenue requests for the TDA, STA, and AB 1107 revenues listed on Document A(c), the Revenue Detail tab. The specific revenues being requested are automatically linked to Document A(b), the Claim Summary.

Document F(b) - Operating Data (Spreadsheet)

Document F(b) is the essential operating statistics reporting tab. It contains the cells within which operating statistics may be entered by transit mode.

Document F(c) - Capital Allocation Requests (Spreadsheet)

Document F(c) is the essential financial reporting tab for capital project expenses and revenues. It contains the cells within which capital project expenses and revenues may be entered by transit mode. It summarizes these mode level entries to the system level. It also provides the cells for entering capital revenue requests for the TDA, STA, AB 1107, and Bridge Toll revenues listed on Document A(c), the Revenue Detail tab. The specific revenues being requested are automatically linked to Document A(b), the Claim Summary. This document does not need to be completed if capital funding is not requested.

Document G(a) - Productivity Improvement Program (PIP) Project Report (Spreadsheet)

Document G(a) is used to report progress in implementing the claimant's projects in the Productivity Improvement Program. A progress report must be filed through project completion.

Document G(b) - Productivity Improvement Program Development (Spreadsheet)

Document G(b) is used to identify new projects for the Productivity Improvement Program. Document G(a) is used to report progress on existing projects in the Productivity Improvement Program.

Document H(a) - Maximum Allocation Worksheet - (Spreadsheet)

Document H(a) is the Maximum Allocation worksheet and used to calculate Farebox Recovery Ratio and Farebox Plus Local Support Recovery Ratio for Article 4 claimants.

Document H(b) - Maximum Allocation Worksheet - Article 4.5 or 8 (Spreadsheet)

Document H(b) is the Maximum Allocation Worksheet for calculating Farebox Plus Local Match Recovery Ratio for Article 4.5 and 8 claimants.

Document H(c) - Maximum Allocation Worksheet - 50% Expenditure Limitation (Spreadsheet)

Document H(c) is the Maximum Allocation worksheet for calculating Fifty Percent Expenditure Limitation for certain Article 4 claimants. Claimant should complete

this document on if they plan to qualify for TDA under the 50% expenditure limit, Document I(c).

Document I(a) TDA Eligibility Statement - Article 4 (Spreadsheet)

Document I(a) is the Claimant Eligibility Statement for Article 4 claimants establishing eligibility through the Farebox Recovery Ratio and/or establishing eligibility through the Farebox Plus Local Support Recovery Ratio. Claimants choose either Document I(a) or Document I(c).

Document I(b) TDA Eligibility Statement - Articles 4.5 & 8 (Spreadsheet)

Document I(b) is the Claimant Eligibility Statement for Article 4.5 and 8 establishing eligibility with the Farebox Plus Local Support Recovery Ratio.

Document I(c) - Eligibility Statement - 50% Expenditure Limitation (Spreadsheet)

Document I(c) is the Claimant Eligibility Statement for Article 4 claimants establishing eligibility through the Fifty Percent Expenditure Limitation formula. Claimants choose either Document I(a) or Document I(c).

Document I(d) - STA Eligibility Calculation – Article 4 (Spreadsheet)

Document I(d) is the STA eligibility calculation for claimants claiming STA funds.

Document J(a)- Standard Certifications - Article 4 (Spreadsheet)

Document J(a) is the Standard Certifications for Article 4 applications.

Document J(b) - Standard Certifications - Articles 4.5 & 8 (Spreadsheet)

Document J(b) is the Standard Certifications for Article 4.5 and Article 8 transit applications.

Document K - CHP Pull Notice Program (Claimant)

Evidence of compliance with the California Highway Patrols Pull Notice Program (form CHP 339) must be submitted with each transit claim if claimant employs drivers.

Document 1107 - AB 1107 Request (Spreadsheet)

Document 1107 is for applications for AB 1107 sales tax revenue.

**Document RM2 + RM3 Certifications – RM2 and RM3 Operating Assistance
Application Certifications (Spreadsheet)**

Document RM2 + RM3 Certifications should be completed by eligible applicants that are eligible for RM2 or RM3 operating funds and are not required to submit document J(a). This document is the Standard Certifications for RM2 and RM3 operating funds.

Document RM2 – Regional Measure 2 Operating Assistance Proposal (Spreadsheet)

Document RM2 should be completed by eligible applicants that are eligible for operating funds as identified in Streets and Highways Code Section 99314(d).

Document RM2 is essential for operating costs and revenues for RM2-funded services. It is NOT linked to the summary spreadsheet within this application. It contains cells for entering operating cost and revenue, passengers, revenue hours and miles, and all data necessary for monitoring of the project as required in MTC Resolution 3668. Please complete one sheet for each project RM2 funds are being requested for.

Document RM3 – Regional Measure 3 Operating Assistance Proposal (Spreadsheet)

Document RM3 should be completed by eligible applicants that are eligible for operating funds as identified in Streets and Highways Code Section 99314.7(c). Document RM3 is essential for operating costs and revenues for RM3-funded services. It is NOT linked to the summary spreadsheet within this application. It contains cells for entering operating cost and revenue, passengers, revenue hours and miles, and all data necessary for monitoring of the project as required in MTC Resolution 4404, Revised. Please complete one sheet for each project RM3 funds are being requested for.

Document CEQA – CEQA Documentation (Spreadsheet)

Document CEQA records the CEQA clearances or categorical exemptions for projects seeking TDA Article 4 or 8 funds.

Document X - Explanatory Notes (Spreadsheet)

Document X provides a space where comments can be appended to the application.

Ref Data - Reference Data (Spreadsheet)

No data is entered in Ref Data. The Ref Data tab contains information that is used throughout the application. The codes and descriptions shown on the Ref Data tab are described in more detail in the instructions for Document F(a) of this Fund Application Manual.

Workbook Instructions

The first three tabs of the workbook are the Application Checklists. The Checklists are a way of confirming for yourself that your claim is complete before you submit it to MTC. It is anticipated that these documents will be completed after all of the remaining claim documents have been compiled and completed. Starting with Document A(a), the spreadsheet is intended to be completed from left to right. This sequence of completing the tabs from left-to-right is not only important for the workbook to function correctly, but especially important if different individuals in your organization are responsible for completing different tabs. In other words, in this case you will need to schedule work on the tabs according the left-to-right sequence, or incorrect claim information may result.

The claim workbook is password protected. If for any reason you believe you need to alter the layout of a tab document or the workbook, please contact MTC staff.

Cells highlighted yellow, orange or green (depending on which tab you are working in) are cells in which the user enters information either: text, dates, dollar amounts, or percentages. Cells highlighted in blue are cells in which information will appear automatically based on some calculation or reference to another cell in the same tab or in a different tab. Though the workbook displays colored and shaded cells, the colors and shading are disregarded by your printer and do not appear in or affect the printed versions of the documents.

Certain cells have drop-down menus. They are light blue in color. They work by clicking in the light blue cell, then clicking the down arrow and selecting the appropriate entry.

Where the instructions for a document refer to line numbers, these are the line numbers of the document, not the spreadsheet.

Document A(c) Revenue Detail serves as a place to define funds that are being claimed. The information in Document A(c) is linked to other worksheets in the claim document. It does not need to be printed and submitted as part of the claim.

Application Checklists

Document 4, Document 4.5, and Document 8

These checklists contain the list of documents, which must be included in a claim for TDA and/or STA funds. Enter an X in each yellow highlighted cell to confirm that you have completed and are submitting each required Document, including required copies of service contract(s), and/or the certificate of compliance with the California Highway Patrol Pull Notice Program.

Document A – Basic Information

Document A(a) - Claimant Information

- line 1 **Claimant Name** - Enter the claimant name by clicking in the light blue box next to Claimant Name. Then click on the down arrow and pick the appropriate name. The claimant name is now linked to the top of each sheet in the claim workbook.
- line 2 **Street Address** - Enter the mailing address number and street name of the claimant.
- line 3 **City** - Enter city used in the mailing address of the claimant.
- line 4 **ZIP code** - Enter the ZIP code used in the mailing address of the claimant.
- line 5 **County** - Enter the county in which claimant’s main office is located.
- line 6 **Authorized Signature Name** - Enter the name of the individual authorized to submit the claim.

NOTE: this name will automatically appear at the bottom of the documents that require a signature by the authorized individual.

- line 7 **Authorized Signature Title** - Enter the title (employment position) of the individual whose name was entered on line 6.

NOTE: this title will automatically appear at the bottom of the documents that require a signature by the authorized individual.

- line 8 **CFO Name** - Enter the name of the claimant’s chief financial officer, or the name of the person who acts in this capacity.

NOTE: this name will automatically appear at the bottom of the documents that require a signature by the chief financial officer or equivalent.

NOTE: the person identified on line 8 is generally different than the individual authorized to file the claim whose name is entered on line 6.

- line 9 **CFO Title** - Enter the title (employment position) of the individual whose name was entered on line 8.

NOTE: this title will automatically appear at the bottom of the documents that require a signature by the chief financial officer or equivalent.

line 10 **Contact Person Name** - Enter the name of the staff person responsible for submitting the claim.

NOTE: this person may be the same individual whose name is entered on line 6.

line 11 **Contact Person Title** - Enter the title (employment position) of the individual whose name was entered on line 10.

line 12 **Contact Person's Telephone** - Enter the telephone number of the individual whose name was entered on line 10.

line 13 **Contact Person's FAX** - Enter the fax number of the individual whose name was entered on line 10.

line 14 **Contact Person's E-mail Address** - Enter the e-mail address of the individual whose name was entered on line 10.

line 15 **Fiscal Year** - This information was entered by MTC and cannot be changed.

NOTE: the fiscal year (FY 2026-27) that appears at the top of each tab Document is linked to this cell.

line 16 **Claim Date (mm/dd/yyyy)** - Enter the date that you submit the claim to MTC. Use the format mm/dd/yyyy, for example, 06/21/2022 for June 21, 2022.

NOTE: the Submittal Date that appears at the top of each tab Document is linked to the date that is entered on line 17.

lines 17-26 **Mode Code** - Define and name each mode operated by clicking in the light blue box in the **Mode Type** column. Then click on the down arrow and pick the appropriate mode. Please define all modes of public transportation that you operate, regardless of whether your allocation request is specifically to support only certain modes.

Under the column heading **Service Name** type the commonly referred to name of each service, if appropriate. If you operate distinct services of the same mode type, you may enter the same mode code more than once. If there are two or more services associated with a single mode, list the **Service Name** in the yellow space provided to differentiate the services.

Document A(b) - Claim Summary

Document A(b) Claim Summary is the summary of local funds being claimed. This document is automatically generated by the spreadsheet and requires no direct input. Authorized signature and date are required in the space provided.

Document A(c) - Revenue Detail

The Document A(c) Revenue Detail is used to define specific funds that are being claimed, the purpose for which the funds will be used and the proper apportionment area from which the funds are being claimed.

There are five sub-areas of Document A(c):

TDA Operating
STA Operating
TDA Capital
STA Capital
Article 8 Streets and Roads

Information from Document A(c) is automatically linked to Document A(b), Document F(a), and Document F(c). Document A(c) must be completed, but does not need to be submitted with the claim.

Data are entered by clicking in the appropriate light blue colored cell, then clicking on the down arrow and picking the appropriate fund name, purpose and apportionment area.

lines 1-20 **TDA Operating** - Enter the name of the fund being claimed, the purpose and the apportionment area.

lines 21-32 **STA Operating** - Enter the name of the fund being claimed, the purpose and the apportionment area.

lines 33-42 **TDA Capital** - Enter the name of the fund being claimed, the purpose and the apportionment area.

lines 43-46 **STA Capital** - Enter the name of the fund being claimed, the purpose and the apportionment area.

Document B - Authorizing Resolution

Claimants are required to submit an authorizing resolution (21 Cal. Code of Regs. §6630).

Claimants may use their agency's own format as long as it contains all of the following information.

- The name of the County Local Transportation Funds from which funds have been requested.
- The purpose for which funds are requested by project name or transit and/or streets and roads.
- The fiscal year for which funds are requested.
- The Public Utilities Code section under which the claimant qualifies for an allocation of TDA/STA funds, either Public Utilities Code §99260, §99260.2, §99260.5, §99275 or §99400. (Refer to TAB II for a summary of these allocation categories.)
- The title of individual authorized by claimant's governing board to apply for funds on behalf of the claimant.
- The fiscal year for which TDA and/or STA funds are being requested.

Document C - Opinion of Counsel

Each claimant must provide MTC with a current opinion of counsel (21 Cal. Code of Regs. §6630) that addresses the following three points:

- That the claimant is authorized to perform the project for which funds are requested.
- That the claimant is eligible to apply under the Public Utilities Code section(s) cited in the claim form. (Document A(b))
- That there is no legal impediment to the claimant applying for funds and that there is no pending or anticipated litigation that might adversely affect the project or the ability of the claimant to carry out the project.

Document D - Environmental Documentation

Pursuant to Public Resources Code §21000 *et seq.*, all claimants are required to be in compliance with California Environmental Quality Act (CEQA).

In most cases, the claim application is to support existing service, which, following the criteria of negligible or no expansion of an existing use, is a categorically exempt activity under section 15301 of the CEQA Guidelines (Existing Facilities). In this case, the claim application must include a completed Notice of Exemption, file stamped by the clerk-recorder of the county in which the claimant is located. This same requirement for a file stamped copy of a Notice of Exemption would apply in cases where the claim application includes funding requested for a purpose that is statutorily exempt under CEQA.

In other cases, the claim application includes funding requested for a purpose not categorically exempt, but which is determined to qualify for a Negative Declaration as a result of an Initial Study. In this case, the claim application must include a completed Notice of Determination (indicating that a Negative Declaration has been prepared), file stamped by the clerk-recorder of the county in which the claimant is located. Claimant may provide a link to the online documents.

In some cases, the claim application includes funding requested for a purpose which does not qualify as categorically or statutorily exempt, or qualify for a negative declaration, in which case the claim application must include a completed Notice of Determination (indicating the environmental determination that has been made), file stamped by the clerk-recorder of the county in which the claimant is located. Claimant may provide a link to the online documents.

Document E(a) – Description of Claimant, Transit System, Budget Summary, and Operating Highlights

Document E(a) is a description provided by the claimant in response to one or more of the following items. Items should be addressed as applicable and be written in a one-page summary that will be presented to the Commission if claimant receives allocations over \$1 million. If a claimant will not request a claim over \$1 million, the requested information does not need to be provided in a one-page summary. A template can be found in the Related Documents section of the TDA webpage on the MTC website.

- 2. Service Coordination**
(Public Utilities Code §99282)
- 3. Efficiency and Effectiveness** (Article 4 applications)
(Public Utilities Code §99244)
- 4. Description of Capital Program** (as appropriate)
(Public Utilities Code §99261 and 21 Cal. Code of Regs. §6630)
- 5. Significant Budget Provisions**
(21 Cal. Code of Regs. §6632)
- 6. Service Contract (Consolidated Transportation Service Agencies only)**
(21 Cal. Code of Regs. §6683 and §6684)
- 7. Claimant’s Financial and Management Information Data**
(Article 4.5 applications) (Public Utilities Code §99275.5)
- 8. Planning and Administration** (Article 8 transit applications)
(Public Utilities Code §99400(d))
- 9. Description of Unmet Needs** (Article 4.5 applications)
(Public Utilities Code §99275.5)

1. Service and Operations Description

- (a) Describe service area, including transit district boundaries if applicable; if claimant is not a transit district, specify corporate areas served and define unincorporated areas served.
- (b) Describe type(s) of service provided (taxi, van, fixed-route, demand responsive). Describe different modes or programs separately.

- (c) Describe days and hours of operation for each mode or program. Describe routes and service frequencies; describe days and hours of operation.
- (d) Describe in detail any proposed expansion or extension of service proposed in project year. If such service will be exempted from fare or local match requirement or 50 percent expenditure limitation, provide description of how service complies with requirements of 21 Cal. Code of Regs. §6619.1 and §6633.8.
- (e) Describe fare structure, including base fare, zone fares, transfer charges, special category fares, passes, etc.
- (f) For fixed-route service, provide current set of route maps showing all anticipated significant route changes during project year.
- (g) Provide set of public schedules.

2. Service Coordination

- (a) Describe the coordination of service with other providers, including transfer arrangements with emphasis on coordination achieved during past fiscal year. Describe SB602 agreements and any recent update of these agreements. For paratransit claimants, describe how service is consistent with local and regional AB 120 Action Plans and ADA Plans. Describe any issues or problems related to service coordination. If services are not coordinated with other operators in your service area, explain why such coordination is not appropriate or describe plans to achieve coordination in the near future.
- (b) Describe specific coordination efforts and goals that have been considered, especially responding to requests for coordination of service from outside agencies.

3. Efficiency and Effectiveness

- (a) Summarize productivity improvement recommendations made by MTC for the previous fiscal year. Discuss the recommendations made in your most recent performance audit, if applicable.
- (b) Describe specific actions taken in response to these recommendations and progress made in the past year as a result of these responses, and describe proposed actions to be implemented in project year and anticipated results.

4. Description of Capital Program (as appropriate)

- (a) Describe capital budget provisions for facilities, shelters and other non-vehicular purchases. Article 8(c) claimants are eligible for capital expenditures to acquire vehicles and related equipment, bus shelters, bus benches, and communication equipment for their services.
- (b) Describe any proposed fleet additions or replacement purchases.

Reporting Periods - Document F(a) and Document F(b)

Past Actual - Refers to the prior fiscal year. This data should be audited data and consistent with NTD data.

Current Adjusted - Refers to the fiscal year currently in progress. Data should be adjusted to show six months of actual data and six months of estimated data.

Proposed - Refers to the upcoming fiscal year which is generally budgeted in the spring of the current fiscal year. Recognizing that not all operators have approved budgets by April 1, these data may come from a preliminary budget estimate.

Operating Expenses

Average Boardings

Note Average weekday is defined as a representative weekday in the operation of the transit system, computed as the mathematical average of several typical weekdays selected at random throughout the year. A typical weekday is one in which there is no unusually high or low ridership. Unusually high ridership could be caused by anomalous events such as an extended gasoline shortage, bridge closure, or as a result of extra service added for a convention. Unusually low ridership could be caused, for example, by extended periods of inclement weather, or a natural disaster such as a major earthquake.

line 17 **Non-Revenue Vehicle Miles** - Enter the total number of actual miles accumulated by revenue vehicles while not in revenue service. This includes school bus service, charter service, vehicle maintenance and exclusive operator training miles, and deadhead miles. Deadhead miles accrue while a vehicle is enroute to or from revenue service to the garage or storage area, changing routes, etc., and when there is no reasonable expectation of carrying revenue passengers. For non-scheduled, non-fixed-route service (demand responsive), deadhead mileage also includes the travel between the dispatching point and passenger pick-up or drop-off.

line 18 **Total Vehicle Miles** - Spreadsheet calculates the sum of line 16 and line 17.

Annual Vehicle Hours

line 19 **Revenue Vehicle Hours** - Enter the total number of actual hours of service accumulated by revenue vehicles while in revenue service. A vehicle is in revenue service when it is available to the general public and there is a reasonable expectation of carrying passengers that either directly pay fares, are subsidized by public policy, or provide payment through contractual or mutual agreement. line 14 **Federal Cash Grants And Reimbursements** - Enter the total of all federal cash grants and reimbursements under account class 4500 (e.g., FTA Section 5305 planning assistance and FTA Section 5310 operating/ADA assistance).

- line 45 **STA for Other Purposes** - Enter the amount of STA funds (population-based and revenue-based) being requested under this claim for other purposes. Please include an explanation of such other purposes in Document X.
- line 46 **Total Maximum Allocation** - Spreadsheet calculates the sum of lines 33 through 38. This is the total combined TDA and STA allocations allowable for operating, capital, and other qualified purposes.
- line 47 **TDA for Qualified Service Extension** - Enter the amount of TDA to be allocated under this claim for operating support for qualified service extensions.
- line 48 **STA for Qualified Service Extension** - Enter the amount of STA (population-based and revenue-based) to be allocated under this claim for operating support for qualified service extensions.
- line 49 **Operating Fund Request** - Enter the amount of TDA and STA requested for operating support from Form A(b).
- line 50 **Capital Fund Request** - Enter the amount of TDA and STA requested for capital support from Form A(b).
- line 51 **Total Request** - Sum of Line 49 and 50
- line 52 Checks that line 51 does not exceed the maximum allowable request (line 46).

Document H(b) - Maximum Allocation Worksheet – Articles 4.5 & 8

The financial information provided on Document H(b) must pertain only to the public transportation services (e.g., fixed route bus, demand responsive, light rail), which are included together for the purpose of determining the farebox recovery ratio and the farebox plus local support recovery ratio. In other words, the services which together are the subject of a single application for TDA and/or STA funds under eligibility established under an Article 4.5 and 8 farebox plus local match recovery ratio.

This worksheet applies to services operated under TDA Article 4.5 and 8 requirements. TDA Article 4 claimants must use either Document H(a) or Document H(c).

Farebox Revenue

line 1 **Farebox Revenue Excluding Fares Service Extensions** - Enter amount of all expected farebox revenue, excluding revenue from qualified service extensions (see instruction for line 2) from revenue account class (4110):

Qualified service extensions must meet the following test:

Additions of geographical areas or route miles, or improvements in service frequency or hours of service greater than 25 percent of the route total, or the addition of new days of service, and for transit service claimants (Article 4.5 and Article 8 claimants) also includes the addition of a new type of service, such as van, taxi, or bus. This exemption applies for only two years after the end of fiscal year in which the qualified extension of service was put into operation. Within 90 days after the first full year of implementation, the claimant must file a report with MTC on the performance of the service extension, including, but not limited to, the area served, the fare revenue generated, and the cost to provide the additional service. Contact MTC staff for further information on qualified service extensions and reporting requirements. See PUC § 99268.8; Cal. Code of Regs. §§ 6633.8, and 6611.1.

line 3: **Total Farebox Revenue** - Spreadsheet calculates the sum of lines 1 plus line 2.

Local Fund Revenue

PUC Section 99268.19 was revised effective July 1, 2016 to have a more expansive definition of local funds for the purposes of Farebox supplementation in order to meet the applicable TDA-LTF farebox recovery requirement. Local funds now means any nonfederal, nonstate grant funds or other revenues generated by, earned by, or distributed to an operator. Cal. Code of Regs. §6611.3 is now outdated and in the process of revision.

Note on Contributed Services

Under MTC Resolution No. 1209, Revised, contributed services (revenue account class 430) also may be counted as local match, including the contributed service of volunteer drivers, only at a rate not to exceed the federal minimum wage for the number of hours that can be verified by the annual independent fiscal audit and only to the extent that the value of these services is reported as a contra account for expense. Likewise, contributed services of a paid employee of the transit service claimant or another entity shall be valued at a rate not to exceed the hourly wage of that employee for the number of hours that can be verified by the annual independent fiscal audit and only to the extent that the value of these services is reported as a contra account for expense.

- line 4 **Auxiliary Transportation Revenue** - Enter the total of revenue from account class 4140—Auxiliary Transportation Revenues. These are revenues earned from operations closely related to or dependent upon transportation operations (e.g., vendors, advertising).
- line 5 **Taxes Directly Levied** - Enter the total of revenue from account class 4200, Taxes Directly Levied by the Operator of the Transit System (e.g., transit district sales tax).
- line 6 **Local Cash Grants and Reimbursements** - Enter the total of revenue from account class 409.01, Local Cash Grants and Reimbursements for General Operating Assistance. These are revenues provided for support of generally provided service(s) only; not revenues in support of special service(s) or for special projects. Do not include on line 6 the amount of TDA and/or STA anticipated to be received from another city, county, or transit district for service provided within the boundaries of the city, county, or transit district. Do not include on line 6 carryover TDA and/or STA fund from a prior year's allocation.
- line 7 **Local Special Fare Assistance** - These are funds obtained from local government units to help cover or completely cover the difference between reduced fares and full fares.
- line 8 **Subsidy from Other Sectors of Operation** - Enter the total of revenue from account class 440.00, Subsidy from Other Sectors of Operation. These are revenues transferred to public transportation operating purposes from activities not directly related to the

- public transportation purposes (e.g., Golden Gate Bridge, Highway and Transit District transfer of bridge tolls to operating subsidy for transit service).
- line 9 **Federal Cash Grants And Reimbursements** - Enter the amount of federal cash grants and reimbursements other than funding from FTA Section 5307 and FTA Section 5303 per MTC Resolution No. 1209, Revised.
- line 10 **Private Cash Contributions** - Enter the amount of private cash contributions. Attach an explanation of the amount, the donor, and the intended use of the funds. (per MTC Resolution No. 1209, Revised).
- line 11 **Funds from the Older Americans Act of 1965** - Enter the amount of funds provided under the Older American Act of 1965 (as amended). (per MTC Resolution No. 1209, Revised).
- line 12 **Funds from a Regional Center** - Enter the amount of funds provided by a Regional Center for transportation of persons with developmental disabilities (see Calif. Welfare and Institutions Code §4620 et seq.).
- line 13 **Contributed services (contra account only)** - Enter the value of contributed services provided by individuals, outside organizations, and other agencies. However, revenue from contributed services may only be reported to the extent that it is offset by a contra account for expense included in the operating cost as reported on line 23. See note on contributed services at the beginning of these instructions.
- line 14 **Total Local Fund Revenue** - Spreadsheet calculates the sum of lines 4 through 13.
- line 15 **Total Fare-Plus-Local-Fund Revenue** - Spreadsheet calculates the sum of line 1 plus line 14. This total is exclusive of fares from qualified service extensions.
- State and Federal Operating Assistance Grants**
- line 16 **State Cash Grants and Reimbursements** - Enter the total of all state cash grants and reimbursements under account classes 4400.
- line 17 **Federal Cash Grants and Reimbursements** - Enter the total of all federal cash grants and reimbursements under account class 4500 not reported on line 9 (e.g., FTA Section 5303 planning assistance; FTA Section 5307 assistance).
- line 18 **Total State and Federal Operating Assistance** - Spreadsheet calculates the sum of line 16 plus line 17.

Other Operating Purposes

- line 19 **Other Operating Revenue** - Enter the total amount of other operating revenue not included in the lines above. Line 19 could include revenue such as charter service revenue. Include the amount of TDA and/or STA anticipated to be received from another city, county, or transit district for service provided within the boundaries of the city, county, or transit district. Do not include contributed services (430.00).
- line 20 **Other Non-Operating Revenue** – Please identify the USOA code and provide a description of any revenue identified here on Document X.
- line 21 **Total Other Operating Revenue** - Spreadsheet calculates sum of line 19 plus line 20.
- line 22 **Total Revenue (excluding TDA & STA)** - Spreadsheet calculates the sum of line 3 plus line 14 plus line 18 plus line 21. This total includes fares from qualified service extensions. This total does not include any TDA and/or STA.
- line 23 **Operating Costs Excluding Service Extensions** - Enter the total operating cost (excluding the operating cost for qualified service extensions) for all services operated under Article 4.5 and 8 which are the subject of this claim, and for which claim eligibility is being established under a farebox plus local match recovery ratio. Include in this total the amount of contributed services, which must be reported in a contra account for expense.
- line 24 **Operating Costs Of Service Extensions** - Enter the total operating cost for qualified service extensions operated under Article 4.5 and 8 which are the subject of this claim. Include in this total the amount of contributed services allocated to qualified service extensions and which must be reported in a contra account for expense.
- line 25 **Total Operating Cost** - Spreadsheet calculates the sum of line 23 plus line 24.
- line 26 **Operating Deficit** - Spreadsheet calculates the difference of line 25 less line 22. This is the maximum combined TDA and STA allocation(s) allowable for operating purposes for services, which are the subject of this claim.

Exclusions and Exemptions

- line 27 **Depreciation and Amortization Expense** - Enter total depreciation and amortization expenses of plant, equipment, vehicles, inventory and tangible and intangible assets which are maintained for the direct benefit of the services which are the subject of this claim. Depreciation may be pro-rated for depreciable and amortizable property, which is directly used only in part for the support of the services, which are the subject of this

claim. Any reasonable method of assigning pro-rata depreciation and amortization is acceptable

- line 28 **Charter Service Expense** - Enter the direct operating cost of charter service provided. This operating cost should relate to charter service provided for which revenue may have been reported on line 19.
- line 29 **Vehicle Lease Expense** - Enter all vehicle lease expenses. This pertains specifically to revenue vehicles.
- line 30 **Commuter Rail Service Expense** - Enter operating expense resulting from the operation or subsidy paid for commuter rail service operated under the jurisdiction of the Public Utilities Commission.
- line 31 **Service Extension Expense** - Enter qualified service extension operating expenses. In order to qualify as a service extension for purposes of TDA in general and this exemption specifically, the service must meet the test described in the instructions for completing line 2 (see above).
- line 32 **Ridesharing Expense** - Enter expenses for providing ridesharing services, which qualify for this exclusion (PUC §99268.16) under the following definition in PUC §99211.5:
- Ridesharing services means a comprehensive organizational effort which is designed to reduce the number of vehicles on the highways during peak travel periods within a defined area by encouraging the planning and marketing of high-occupancy vehicle facilities, increases in the number of passengers per vehicle in vehicles used for ridesharing alternative work schedules, and other transportation demand management strategies among employers and commuters.
- line 33 **Performance Audit Expense** - Enter the cost of having an independent performance audit conducted of the transit service(s) which is/are the subject of this claim and for which funds are being requested as a part of this claim. This exclusion is contained in MTC Resolution No. 1209, Revised.
- line 34 **Special Planning Study Expense** - Enter the cost of special planning studies and/or demonstration projects which are expected to be undertaken for the benefit of the service(s) which is/are the subject of this claim and for which funds are being requested as a part of this claim. This exclusion is contained in MTC Resolution No. 1209, Revised.

- line 35 **Expense of Paratransit Coordinating Council Staffing** - Enter the direct expense of providing staffing to the county Paratransit Coordinating Council for purposes of planning and administration, and for which funds are being requested as a part of this claim. This exclusion is contained in MTC Resolution No. 1209, Revised.
- line 36 **Total Exclusions and Exemptions** - Spreadsheet calculates the sum of lines 27 through 36

TDA-Defined Ratios

- line 37 **TDA-Adjusted Operating Cost** - Spreadsheet calculates the difference of line 25 less line 36. This is the TDA-adjusted operating cost, used for calculating TDA performance measures (not calculated on this form) and the farebox plus local match recovery ratio.
- line 38 **TDA Fare Recovery Ratio** - Spreadsheet calculates the quotient of line 1 divided by line 37 less line 24. This is the TDA farebox recovery ratio, and is reported here for statistical purposes only; and not for establishing eligibility to claim TDA and STA funds.
- line 39 **TDA Fares-Plus-Local-Fund Recovery Ratio** - Spreadsheet calculates the quotient of line 15 divided by line 37. This is the TDA farebox plus local match recovery ratio for the purposes of determining eligibility for TDA and/or STA funds. This ratio must be entered on Document I(a) line 5 or 6.

Maximum Allocations

- line 40 **Operating Deficit** - Spreadsheet enters the amount shown on line 26—Maximum combined TDA and STA allocation(s) allowable for operating purposes.
- line 41 **TDA for Capital Purposes** - Enter the amount of TDA funds being requested under this claim for capital purposes.
- line 42 **STA for Capital Purposes** - Enter the amount of STA (population-based and revenue-based) funds being requested under this claim for capital purposes.
- line 43 **TDA for Other Purposes** - Enter the amount of TDA funds being requested under this claim for other purposes. Please include an explanation of such other purposes in Document X.
- line 44 **STA for Other Purposes** - Enter the amount of STA funds (population-based and revenue-based) being requested under this claim for other purposes. Please include an explanation of such other purposes in Document X.

- line 45 **Total Maximum Allocation** - Spreadsheet calculates the sum of lines 41 through 45. This is the total combined TDA and STA allocation allowable for operating, capital, and other qualified purposes.
- line 46 **TDA for Qualified Service Extension** - Enter the amount of TDA to be allocated under this claim for operating support for qualified service extensions (see the instructions for line 2 for a definition of qualified service extensions).
- line 47 **STA for Qualified Service Extension** - Enter the amount of STA (population-based and revenue-based) to be allocated under this claim for operating support for qualified service extensions (see the instructions for line 2 for a definition of qualified service extensions).

Document H(c) - Maximum Allocation Worksheet - 50% Expenditure Limitation

Do not complete if using Document H(a)

Calculation of Maximum Eligible Operating Expense

- line 1 **Total System Operating Expense** - Enter total system expense including capital and operations (See Pub. Util. Code §99268). Include principle and interest on bonded indebtedness, casualty and liability insurance premiums, claim settlements (those expenses falling under account class 506), costs of promoting/providing ridesharing services, vehicle lease costs, and direct costs of providing charter services. Do not include payments for subsidies for commuter rail service. If such payments are made by claimant, they are eligible for 100 percent funding and should be included under other on line 9, Exceptions to Expenditure Limitation. - line 4 **Total Adjustments** - Spreadsheet calculates the sum of line 2 and line 3.
- line 5 **Net Expenses** - Spreadsheet calculates the difference of line 1 less line 4.
- line 6 **Net Eligible Expenses** - Spreadsheet calculates 50 percent of line 5. This amount represents the maximum TDA/STA for which the claimant is eligible under Pub. Util. Code §99268. Exceptions to this limitation are discussed below.

Calculation of Maximum Eligible Allocation

- line 7 **Qualified Service Extension** - Enter total TDA/STA funds requested for service extensions pursuant to Pub. Util. Code §99268.8. (line 7 should never exceed the amount shown on line 2 above.)
- line 8 **Capital Intensive Projects** - When TDA/STA funds remain unallocated because of the 50 percent expenditure limitation, MTC may allocate such funds for capital-intensive transit-related improvements in accordance with Pub. Document I – Eligibility Statement

Document I(a) – TDA Eligibility Statement - Article 4

Any Article 4 operator that is able to qualify under both the fare ratio requirement and the 50 percent expenditure limitation may choose the basis under which to qualify for an allocation of TDA/STA funds. Claimants that choose to qualify on the basis of maintaining a certain ratio of fares or fares plus local support to total operating cost must complete this form.

Article 4 Claimants

In order to be eligible for TDA funds, Article 4 operators must meet certain eligibility criteria. Typically, the eligibility criteria most often used is the farebox recovery ratio. Starting with claims for FY 2016-17, the statutes pertaining to farebox recovery standards for Article 4 claims was revised. Each operator must also determine its minimum required farebox recovery ratio, based on whether or not it provides service in urbanized or non-urbanized areas.

Operators may also be eligible for claim under Article 4 by meeting farebox recovery standards by coordinating that determination with BART. Operators who would like to comply with Article 4 eligibility standards under this provision should contact MTC to discuss use of this option first.

Operators providing service to an urbanized area in counties under 500,000 population as determined by the federal census may comply with the farebox recovery ratio set by MTC, which cannot, however, be less than 15 percent. Operators wanting a reduced farebox recovery should contact MTC to discuss use of this option. Prior to setting the required ratio, MTC shall make findings specifying the reasons for its action.

After claimants have determined the appropriate farebox recovery ratio (Article 4) and/or farebox including local support recovery ratio upon which to establish its eligibility, the claimant must submit a budget that reflects this minimum required ratio (project year budget).

I ARTICLE 4 FAREBOX RECOVERY RATIO OPTIONS

- line 1 Spreadsheet copies the calculated Fare Recovery Ratio from Document H(a)
- line 2 Spreadsheet copies the calculated Fares-Plus-Local-Fund ratio from Document H(a).

- line 5 In accordance with PUC §99268.2, or §99268.3, or §99268.4, an operator serving a nonurbanized area and is required to achieve a fare recovery ratio equal of at least ten percent. Enter the TDA Fare Recovery Ratio from line 1, above.
- line 6 If fare revenue is insufficient to meet the farebox recovery ratio, the farebox may be supplemented with “local funds” as defined by PUC Section 99268.19 in order to meet the farebox eligibility standards. Enter the TDA Fares-Plus-Local-Funds Recovery Ratio from line 2, above.
- line 7 In accordance with PUC §99268.5, the operator is claiming funds to provide services using vehicles for the exclusive use of elderly and handicapped persons, and is required to achieve a fare recovery ratio equal to its FY 1978-79 base year fare recovery ratio, or ten percent, whichever is greater (operators not in service in FY 1978-79 are subject to the ten percent requirement). In a county which had less than 500,000 population as determined by the 1970 federal census and more than 500,000 in population as determined by the 1990 census, the required fare recovery ratio is at least twenty percent, if serving an urbanized area, and at least ten percent, if serving a nonurbanized area. (Use PUC §99268.5 only when NOT submitting a combined claim for Article 4 funded general public and Article 4 funded exclusive elderly and handicapped services.) Enter the TDA Fare Recovery Ratio from line 1, above.
- line 8 If fare revenue is insufficient to meet the farebox recovery ratio, the farebox may be supplemented with “local funds” as defined by PUC Section 99268.19 in order to meet the farebox eligibility standards. Enter the TDA Fares-Plus-Local-Funds Recovery Ratio from line 2, above.
- line 9 In accordance with PUC §99270.5, the operator provides service within the service area of the Bay Area Rapid Transit District, and is requesting that MTC make a determination that it is in compliance with PUC §99268.1, §99268.2, §99268.3, §99268.4 or §99268.5, as the case may be, on the basis that the its service is coordinated with BART's. Enter the TDA Fare Recovery Ratio from line 1, above.
- line 10 If fare revenue is insufficient to meet the farebox recovery ratio, the farebox may be supplemented with “local funds” as defined by PUC Section 99268.19 in order to meet the farebox eligibility standards. Enter the TDA Fares-Plus-Local- Funds Recovery Ratio from line 2, above.

- line 11 In accordance with PUC §99268.12, the operator is in a county with 500,000 population or less and serves an urbanized area, and MTC has made findings related to and set the required fare recovery ratio at less than twenty percent, but not less than fifteen percent. Enter the TDA Fare Recovery Ratio from line 1, above.
- line 12 If fare revenue is insufficient to meet the farebox recovery ratio, the farebox may be supplemented with “local funds” as defined by PUC Section 99268.19 in order to meet the farebox eligibility standards. Enter the TDA Fares-Plus-Local- Funds Recovery Ratio from line 2, above.
- line 13 In accordance with PUC §99270.2 (applicable to newly-designated urbanized areas) the operator is requesting a recovery ratio exemption. Enter the TDA Fare Recovery Ratio from line 1, above.
- line 14 If fare revenue is insufficient to meet the farebox recovery ratio, the farebox may be supplemented with “local funds” as defined by PUC Section 99268.19 in order to meet the farebox eligibility standards. Enter the TDA Fares-Plus-Local- Funds Recovery Ratio from line 2, above.
- line 15 Indicate the year covered by the exemption.
- line 16 If operator has failed to comply with fare or fares-plus-local-support recovery ratio requirement, list the years in the space provided. See PUC §99268.9 for a discussion of the Penalty Due to Noncompliance.

Certification: The certification statement must be signed by both the individual named in the authorizing resolution (Document B) and by the claimant’s chief financial officer or equivalent.

- line 1 Spreadsheet copies the TDA Fares-Plus-Local-Funds Ratio from Worksheet H(b).
- line 2 Pursuant to PUC §99275.5 (for Article 4.5 claimants) or PUC §99405(c) (for Article 8 claimants), operator qualifies under MTC Resolution No. 1209, Revised as a Special Transit Service claimant, and is required to achieve a fares-plus-local-funds recovery ratio (as defined in MTC Resolution No. 1209, Revised) of a minimum ten percent. Enter the Budgeted Fares-Plus-Local-Funds Recovery Ratio from line 1, above.
- line 3 Pursuant to PUC §99275.5 (for Article 4.5 claimants) or PUC §99405(c) (for Article 8 claimants), operator does not qualify under MTC Resolution No. 1209, Revised as a Special Transit Service claimant, and is required to achieve a fares-plus-local-match recovery ratio (as defined in MTC Resolution No. 1209, Revised) of a minimum twenty percent. Enter the Budgeted Fares-Plus-Local-Funds Recovery Ratio from line 1, above.
- line 4 In accordance with PUC §99268.12, and MTC Resolution No. 1209, Revised, the operator is in a county with 500,000 population or less and serves an urbanized area, and in a prior fiscal year MTC made findings (or is requested to make findings for the budget fiscal year) related to the size and density of the urbanized area in which the services to the general public are provided, and the proportion of the operator's ridership which is transit dependent (including elderly, handicapped and low income patrons), and MTC has set (or is requested to set) the required fares-plus-local-match recovery ratio at less than twenty percent, but not less than fifteen percent. Enter the Budgeted Fares-Plus-Local-Funds Recovery Ratio from line 1, above.
- line 5 In accordance with PUC §99270.2 (applicable to newly-designated urbanized areas) the operator is requesting a recovery ratio exemption. Enter the Budgeted Fares-Plus-Funds-Match Recovery Ratio from line 1, above.
- line 6 Indicate the year covered by the exemption.
- line 7 If an operator has failed to comply with fare or fares-plus-local-support recovery ratio requirement, list the years in the space provided. See PUC §99268.9 for a discussion of the Penalty Due to Noncompliance.

Operators claiming eligibility under the 50% Expenditure Limitation (AC Transit, San Francisco Muni, Golden Gate Transit and VTA) need only sign the statement provided:

The claimant named below establishes its eligibility for an allocation of Transportation Development Act (TDA) and/or State Transit Assistance (STA) funds on the basis that it was in compliance with the expenditure limitation of Public Utilities Code §99268 in fiscal year 1978-79, and on the basis that its proposed FY 2005-06 budget reflects the combined expenditure of TDA and STA funds in an amount that will not exceed fifty percent of total expenditures for its public transportation system, exclusive of expenditures for qualified extensions of service, capital improvements to a grade-separated transit system, and capital intensive projects, in accordance with the provisions of Public Utilities Code §99268.1 and 21 California Code of Regulations §6633.1.

STA eligibility in the MTC region is defined by PUC 99314.7:

99314.7. (a) In allocating funds for operating purposes pursuant to Sections 99313 and 99314, the Metropolitan Transportation Commission shall apply the following eligibility standards to the operators within the region subject to its jurisdiction:

(1) An operator is not eligible for its full allocation under this section unless the operator has been found to have made reasonable effort in implementing productivity improvements pursuant to Section 99244. In determining whether a reasonable effort has been made, the Metropolitan Transportation Commission shall give consideration to whether the operator would qualify for funding under Section 99314.6. The amount of funds allocated shall be reduced in an amount that the Metropolitan Transportation Commission deems proportionate to the failure of the operator to implement the recommended improvements. The Metropolitan Transportation Commission shall adopt rules and regulations, in cooperation with the affected operators, governing the allocation of any funds withheld under this paragraph, subject to paragraphs (2) and (3).

(2) Notwithstanding paragraph (1), an operator shall not receive any funds pursuant to Section 99313 or 99314 unless it has complied with the applicable rules, and regulations, and recommendations adopted by the Metropolitan Transportation Commission pursuant to Section 66516 and 66516.5 of the Government Code.

(3) Funds withheld from allocation to an operator pursuant to paragraph (1) shall be retained by the Metropolitan Transportation Commission for reallocation to that operator for two years following the year of ineligibility. With respect to the funds withheld from an operator pursuant to paragraph (1), the Metropolitan Transportation Commission shall reallocate those funds to the operator if the operator complies with that paragraph within two years. Funds not reallocated to the operator, and funds withheld pursuant to paragraph (2), shall be allocated to any eligible operator within the region subject to the jurisdiction of the Metropolitan Transportation Commission for the purpose of improving coordination among the operators, or to any operator whose increase in total operating cost per revenue vehicle hour is less than the increase in the Consumer Price Index. Funds allocated for these purposes are exempt from subdivision (a).

(b) For purposes of this section, operating cost, revenue vehicle hour, and Consumer Price Index have the same meaning as defined in Section 99314.6.

There are two efficiency standards. Efficiency Standard 1 states that an operator's cost per revenue vehicle hour in the most recent audited year should be equal to or less than the cost per revenue vehicle hour in the prior year increased by the change in the regional CPI for the same period. If the claimant fails Efficiency Standard 1, the claimant continues to Efficiency Standard 2.

Efficiency Standard 2 states that an operator's total operating cost per revenue vehicle hour in the most recent audited year should be equal to or less than the sum of the average total operating cost

per revenue vehicle hour for the three prior years plus an amount equal to that average cost increased by the average percentage change in the CPI for the same three years.

For purposes of determining STA fund eligibility, MTC will use the CPI for all Urban Consumers in the San Francisco Bay Area.

Column 2 - Current Year Revised numbers entered should be a combination of actual and estimated numbers within the current, incomplete fiscal year.

Column 3 – the Budget column is the year you are requesting operating funds for and contains estimates based on your RM2 budget.

Columns 4-8 - enter estimated numbers for all five columns following the budget year you are requesting funding for.

line F1 – Total Operating Cost – this is the total cost of the entire service for the fiscal year.

line F2 – Fare Revenue – enter the total fare revenue for the project for the fiscal year. Check the appropriate box to show if the fares reported are for the entire service or just the RM3 increment.

line F7 - Total Subsidy – these cells will automatically become populated when lines F3 through F6 are filled in for the total service.

line F8 – Total Revenues - these cells will automatically become populated when lines F2 through F6 are filled in.

line F9 - Surplus/(Deficit) – these cells will automatically become populated when line F1 is filled in and line F7 is populated. This line should equal zero. If it does not equal zero, adjustments should be made to the amount of RM3 revenue used or to the amount of subsidy contributed. RM3 must be reduced if there is a surplus.

lines H5-H10 Performance Measures Transbay Terminal– enter estimate annuals boardings, percent of trips from Salesforce Center on time, changes in lease revenue , whether maintenance document, investment/policy summary, financial documents were provided to MTC.

line 11 Performance Measures Transbay Terminal– indicate whether an annual meeting with TJPA and MTC staff has been held

line 12 Performance Measures Transbay Terminal –enter percent of near term STC wayfinding recommendations that have been implemented in the given fiscal year

Document CEQA – CEQA Documentation
