**Contract Change Order – Spare Parts Inventory, Express Lane Toll System Integrator
(TSI): TransCore, LP (\$400,000)**

Subject:

A request for approval to enter into a contract change order with TransCore, LP (TransCore) to add funds in an amount not to exceed \$400,000 to replenish the Bay Area Infrastructure Financing Authority (BAIFA) Interstate 680 (I-680) and Interstate 880 (I-880) Express Lanes spare parts inventory.

Background:

The Fiscal Year (FY) 2023-24 BAIFA Express Lane Rehab Budgets included \$200,000 each for I-680 and I-880 designated for toll system spare parts. This action seeks authority to add these budgeted funds to TransCore's contract at the Executive Director's or designee's determination. After a competitive selection, BAIFA awarded the Toll System Integrator (TSI) contract to TransCore in June 2014 for the implementation and operation of the toll system for BAIFA's express lanes on I-680, I-880 and I-80 and other corridors that might be added. The I-680 corridor began operations in 2017 and the I-880 corridor in 2020. Tolling equipment for these corridors is no longer under warranty. Staff will utilize funds to replenish the spare parts inventory for aging equipment including, but not limited to, LED panels for the Variable Toll Message Sign (VTMS), power supplies, violation enforcement cameras, transponder readers, vehicle detection systems, uninterruptible power supply (UPS) units, controllers, and traffic sensors as well as hardware and software components for the toll collection application system. As reported in September, staff is planning to replace the toll system over in the next several years as the host and corridor equipment reaches the end of its life-cycle, and has accounted for this replacement in the 10-Year Financial Plan.

Issues:



Purpose of Project: Design, implement, and operate express lanes in the Bay Area
