1 Valley Link Passenger Rail
Funding Needed: \$1.95 billion

2 I-80 and U.S. 50 Yolo Managed Lanes
Funding Needed: \$265 million
 Reduce congestion, encourage carpooling, and improve freight movement. 3 ACE/San Joaquin Valley Rail Expansion
Funding Needed: \$600 million
 Provide an alternative to congested I-5 and Highway 99, and deliver rail connections from Sacramento and the northern San Joaquin Valley to the Bay Area. Valley Rail will serve downtown Sacramento and the northern San Joaquin Valley to the Bay Area.

4 I-5 Sacramento Managed Lanes
Funding Needed: \$422 million
 Reduce congestion, encourage carpooling, and improve freight movement. Managed Lanes along both directions of I-5 from the I-5/I-80 interchange to the I-5/I-80 interchange.

5 Intermodal HUB
Funding Needed: \$195 million
